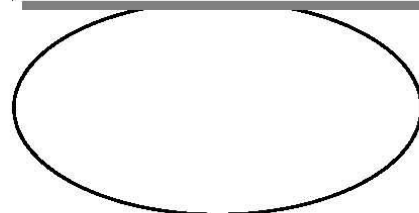

## **INSTRUCTIONS TO APPLICANTS**

1. Contractors registered in Qatar only are eligible for registration with Ooredoo.
2. Contractors are required to submit the following:
  - A. Company Profile.
  - B. List of Names, Titles of Staff including labour force which shall be certified by the Govt. Civil Services Bureau / Labour Dept.
  - C. List of Projects completed during the last five years with capital for financial capability (**if available**).
  - D. List of Plant & Machinery which shall be attested by the Traffic Dept.
  - E. Central Tender Committee Certificate (**if available**).
3. Ooredoo shall reserve the right to inspect the Contractor's premises, Labour camp, Plant & Machinery.
4. The successful Contractor shall not give, bargain, sell, sub-let or otherwise dispose of the Contract or any part thereof or the benefit or advantage of the Contract or any part thereof without the prior consent in writing of Ooredoo.
5. Upon successful evaluation by Ooredoo, pre-qualified Contractors are required to fulfill following requirements.
  - A. Obtain Ooredoo Specifications against payment of **Qrs. 500/=**.
  - B. A prescribed Bank Guarantee in favor of Ooredoo for the value and the period as specified.
  - C. Contractors All Risks Insurance Policy.
  - D. Third Party Liability.
  - E. Contractor's Workmen, Compensation policy.
6. All new contractors will be categorized initially under D category regardless their manpower and machinery, for a probationary period of 6-12 months, and will be either confirmed, upgraded or disqualified based on of their performance.
