1. FIFA World Cup 2026™ TV Pack offer is an optional promotional feature, and customers can activate Home+ Go Entertainment plan without it or buy it as a standalone service for the price of 730 QAR.
2. The Promotional Period is between 21 May and 19 July 2026.
3. A minimum contractual period of twelve (12) months applies.
4. The TV Pack must be redeemed on Ooredoo App.
5. Liabilities for the TV Pack apply. Specifically, early termination or changes of Home+ GO Entertainment plan will result in a prorated charge of QR 730 for the TV Pack, based on the remaining months in the commitment (e.g., after 7 months, pay $5/12$ of QR 730 = QR 304).
6. Other liabilities for early termination as described in the tariff C05-03 and C05-05 apply.
7. Installation is provided for no extra charges while onboarding. However, in case of early termination, customers will need to pay the prorated part of the installation charge of QAR 300.
