Terms & Conditions

1. Customers will be eligible for the Promotion when it is activated online or via retail channels.

3. After the benefits expire, the customer will automatically be reverted to the standard monthly rental.
4. The Promotion is applicable only to new lines and migrations from prepaid to postpaid mobile services.
5. In case the Eligible Customers already benefiting from the promotion upgrade their plans during the promotion period, they will get the benefits of the new plan for the remaining period applicable to the duration of the Promotional benefit.
6. Eligible Customers that downgrade their plans will lose the Promotional benefits.
7. The minimum service period of three (3) months applies. If customer terminates service earlier than 3 months liability fees will be equal to standard plan rates.
8. All Terms and Conditions of the individual tariff (C10-01) apply.
